# CONDITIONS OF PARTICIPATION

## 10. Eligibility

Participation is open to all legal and natural persons which are established in a Member State of the European Union or in a country or territory of the regions covered and/or authorised by the specific instruments applicable to ENI CBC Mediterranean Sea Basin Programme under which this contract is financed.

**Tenderers will also have to meet the criteria set by national authorities for the ENI CBC MED Programme as indicated in the National Requirements document included in this tender dossier.**

Please be aware that after the United Kingdom's withdrawal from the EU, the rules of access to EU procurement procedures of economic operators established in third countries will apply to candidates or tenderers from the United Kingdom depending on the outcome of negotiations. In case such access is not provided by legal provisions in force at the time of contract award, candidates or tenderers from the United Kingdom could be rejected from the procurement procedure.

## 11. Number of tenders

No more than one tender can be submitted by a natural or legal person whatever the form of participation. In the event that a natural or legal person submits more than one tender, all tenders in which that person has participated will be excluded.

## 12. Grounds for exclusion

As part of the tender, tenderers must submit a signed declaration, included in the **tender form**, to the effect that they are not in any of the exclusion situations listed in Section 2.6.10.1. of the practical guide PRAG (see declaration of honour included in the tender dossier).

Tenderer included in the lists of EU restrictive measures at the moment of the award decision cannot be awarded the contract.

## SELECTION AND AWARD CRITERIA

### 16. Selection criteria

The following selection criteria will be applied to the tenderers.

**1. Professional capacity of the tenderer** (based on items 4 of the tender form). The reference period which will be taken into account will be the last three years preceding the submission deadline.

- At least 1 staff currently works for the tenderer in fields related to this contract.
- The expert/s proposed for this contract can operate in fluent English.

**2) Technical capacity of tenderer** (based on item 5 of the tender form). The reference period which will be taken into account will be the last three years preceding the submission deadline.

- Development of a software based on the Retecycle digital dual tracking with mass balance system.
- Development of pilot test of the developed system and adjust the platform with the data obtained from the pilot.

Previous experience which would have led to breach of contract and termination by a contracting authority shall not be used as reference.

### 20. How tenders may be submitted

Tenders must be submitted in English exclusively to the Contracting Authority, using the means specified in point 7 of the **Instruction to Tenderers**.

Tenders submitted by any other means will not be considered.

By submitting a tender tenderers accept to receive notification of the outcome of the procedure by electronic means.

### **21. Alteration or withdrawal of tenders**

Tenderers may alter or withdraw their tenders by written notification prior to the deadline for submission of tenders. No tender may be altered after this deadline.

Any such notification of alteration or withdrawal shall be prepared and submitted in accordance with point 9 of the instructions to tenderers. The outer envelope (and the relevant inner envelope if used) must be marked 'Alteration' or 'Withdrawal' as appropriate.
